Waiver and Release from all Claims

As a skating instructor, I consent to the use of a jump harness in my training of its use. I have inspected the jump harness and the related apparatus and understand its use as represented in the following paragraph.

I consent to the use of a jump harness in the instruction of my student's ice skating routines. I understand that a belt will be attached to the user's waist in order to lift the user three to five feet off the ice surface, to be pulled along, and then lifted during the jump. I understand that I will supervise and assist in the procedure as the user's skating instructor.

I represent that I am in sufficiently good physical condition to participate in the activities of the jumping harness without jeopardizing my student's health. I understand that I have given up substantial rights by signing this waiver and release and sign it voluntarily. I acknowledge that if conditions are unsafe, I will immediately discontinue participation in the activity.

I fully understand that skating involves risks of serious bodily injury, including, but not limited to, permanent disability, paralysis, and death, and that these and other risks may be caused by my own actions, or in-actions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the Releases named below. I fully understand that there may be other risks either not known to me or not foreseen at this time, and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of participation in the activity.

I understand that it is my responsibility to set up and secure the harness in the supplied "Lock Box" after use. I understand that a student is limited to a 15 minute session, per rotation of skaters and that Uxbridge Skating Club members have right of first refusal when using the harness. I understand the user's hair must be secured and that all jewellery must be removed. I will adhere to the rules and regulation policy set out by the Uxbridge Skating Club. I understand that there will be a daily log book that will be filled out every time the harness is used and that it is my responsibility and obligation to "sign in" coach, student and time of use.

Uxbridge Skating Club hereby releases the Township of Uxbridge, Uxbridge Arena, its staff and agents from any and all liability for any injury sustained by any member of the Uxbridge Skating Club, its staff or anyone associated with the Port Perry Skating Club regardless of how caused, resulting from the use of the skating harness. The Uxbridge Skating Club agrees to indemnify and save harmless the Township of Uxbridge, Uxbridge Arena, and its staff and agents from any and all, suits, demands, torts, and actions of any kind which may be brought against its staff or agents for which it/they may become liable by reason of any injury, loss, damage or death resulting from, or occasioned to, or suffered by any person or any property, by reason of any act, neglect or default of the skating harness.

I hereby release, discharge, and if covenant not to sue the USC, its respective administrators, directors, agents, officers, volunteers, and employees, and any sponsors/advertisers of any USC event in which I participate (each considered on of the Releases herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releases. This release waiver of liability and express assumption of the risk agreement does not apply to any liability, claims, demands, losses, or damages arising out of the gross negligence of, or intentional, willful or wanton misconduct of Releases. If I, or anyone in my and/or my student's behalf, makes a claim which does not arise from the gross negligence of, or intentional, willful, wanton misconduct of Releases against any of the Releases, I will indemnify, defend, save, and hold harmless each of the Releases from any loss, liability, damage, or cost which may incur as a result of such claim.

I acknowledge that I have read this release, waiver of liability and express assumption of risk agreement and fully understand it.
